

Seclusion & Restraint Report for FY 25-26 Q2

October 2025

There were 17 admissions with no duplications in October.

There were 459 bed days for this month.

There was 1 seclusion for 80 minutes which works out to 2 seclusions per 1000 bed days. The goal for number of seclusions per 1000 bed days is ≤ 40 minutes. The goal for seclusion time is ≤ 45 minutes.

There were 2 restraints for an average of 59 minutes which works out to 4 restraints per 1000 bed days. The goal for number of restraints per 1000 bed days is ≤ 23 . The goal for average number of minutes in restraints is ≤ 45 minutes.

The total number of clients with an incident was 2 which equates to 11.8% of the 17 admissions.

November 2025

There were 18 admissions with no duplications in November.

There were 415 bed days for this month.

There were 5 seclusions for an average of 27 minutes which works out to 12 seclusions per 1000 bed days. The goal for number of seclusions per 1000 bed days is ≤ 40 minutes. The goal for seclusion time is ≤ 45 minutes.

There were 6 restraints for an average of 59 minutes which works out to 14 restraints per 1000 bed days. The goal for number of restraints per 1000 bed days is ≤ 23 . The goal for average number of minutes in restraints is ≤ 45 minutes.

The total number of clients with an incident was 3 which equates to 16.7% of the 18 admissions.

December 2025

There were 16 admissions with no duplications in December.

There were 393 bed days for this month.

There were 5 seclusions for an average of 73 minutes which works out to 13 seclusions per 1000 bed days. The goal for number of seclusions per 1000 bed days is ≤ 40 minutes. The goal for seclusion time is ≤ 45 minutes.

There were 9 restraints for an average of 42 minutes which works out to 23 restraints per 1000 bed days. The goal for number of restraints per 1000 bed days is ≤ 23 . The goal for average number of minutes in restraints is ≤ 45 minutes.

The total number of clients with an incident was 6 which equates to 37.5% of the 16 admissions.

FY 25/26 Q2

There were 51 admissions (Average = 17) with no duplications for Q2.

There were 1267 (Average = 422) bed days for this period.

There were 11 seclusions (Average = 4) for an average of 53 minutes which works out to 9 seclusions per 1000 bed days. The goal for number of seclusions per 1000 bed days is ≤ 40 minutes. The goal for seclusion time is ≤ 45 minutes.

There were 17 restraints for an average of 39 minutes which works out to 13 restraints per 1000 bed days. The goal for number of restraints per 1000 bed days is ≤ 23 . The goal for average number of minutes in restraints is ≤ 45 minutes.

The total number of clients with an incident was 11 which equates to 21.5% of the 51 admissions.
